



## 2023 LSSC Sunset Race Series

### Notice of Race

**Spring:** May 17 – Jun 21, **Summer:** Aug 2 – Sep 6

1. **RULES:** The series will be governed by the rules as defined in *The Racing Rules of Sailing*.
2. **ENTRY:** All monohull entrants must be MWPHRF ratable yachts of conventional hull design with bunks and head, auxiliary power, self-righting, self-bailing cockpits and fulfill U.S. Coast Guard regulations. All multihull entrants must be GLMRA ratable yachts. The LSSC Race Committee will assign a rating to any yacht without a valid rating certificate.

Eligible boats may enter by completing the Application, found at [www.LakeShoreSailClub.org](http://www.LakeShoreSailClub.org), and sending it with the required fee before the first race of the series.

3. **FEES:**

Spring Series:	\$70	(add late fee after May 12)
Summer Series:	\$70	(add late fee after July 28)
Both Series:	\$130	(add late fee after May 12)
Late Fee:	\$25	

4. **SCHEDULE:** Each of the two series will be run on six consecutive Wednesday evenings, with the first start at 1900 hours.

<b>Spring Series:</b>	May 17, 24, 31, Jun 7, 14, 21
<b>Summer Series:</b>	Aug 2, 9, 16, 23, 30, Sep 6
<b>Awards:</b>	Sep 13

6. **RESULTS:** Individual Race results will be announced after each race at **Dragon's Landing**, 24409 Jefferson Ave, St Clair Shores. 7. **AWARDS:** First, Second and Third place Series awards shall be given for each class. First, Second and Third place Overall awards shall be presented for each Series as well as the combined series. These flags will be presented at **K of C Hall**, 25003 Little Mack, St. Clair Shores at 1900 hours on **September 13**. Free beer, pop and pizza will be provided.
